

TEMPORARY CESSATION OF SOUTH AFRICAN TAX RESIDENCY APPLYING A DOUBLE TAXATION AGREEMENT (DTA)

A DTA generally ensures that a taxpayer is not unfairly taxed in South Africa as well as their chosen foreign host country. This best fits expatriates living and working abroad, but intend to return to South Africa within a few years. Fortunately, South Africa holds dozens of DTAs with various countries around the world, including some of the main South African expatriate destinations, such as Australia, Germany, Ghana, Ireland, Netherlands, Saudi Arabia, the United Arab Emirates, the United Kingdom, and the United States of America.

The main advantage of applying a DTA is that it is a less permanent solution compared to the Financial Emigration process (permanent cessation of South African tax residency), meaning that a taxpayer living and working abroad can apply the DTA and be fully exempt from paying taxes in South Africa on their foreign sourced income. It thus provides a defence against double taxation.



This process effectively ceases your tax residency with the South African Revenue Service (SARS). While the South African Reserve Bank is no longer involved in the application process, financial emigration offers legal certainty regarding your non-resident tax status, which is also necessary for exchange control purposes.

Financial emigration also carries certain financial planning benefits. For instance, it provides one of the few avenues for accessing your retirement annuities before maturity date, provided you can demonstrate non-tax residency for a consecutive period of three years.

At Financial Emigration, we streamline the entire process for you. This includes assessing your financial position and tax status according to SARS records, addressing any retrospective tax corrections and backdating if necessary, completing and submitting your cessation of residence application with SARS, obtaining a Tax Compliance Status PIN, assisting with any Capital Gains Tax (CGT) events triggered by the process, facilitating offshore fund transfers, redeeming policies, and more.
